**2. Background:**

Stampede Meats Inc. is recalling approximately 739,000 pounds of frozen raw beef products. Investigations because of several illnesses due to Escherichia coli O157:H7 in the States of Minnesota, Michigan and Kansas, have revealed that five illnesses may be linked to the above recalled products epidemiologically. Public health officials from FSIS, CDC and several state health departments are continuing to investigate the extent of the outbreak.

**3. Production Dates/Identifying Codes:**

Produced between March 17 and March 22, 2003. Below is a list of products subject to the recall. The majority of products are packaged in cases. Each products bear the establishment code "EST. 19113" inside the USDA mark of inspection.
