No other KRAFT HANDI-SNACKS pudding products are part of the recall. We have had no reports of illness associated with the recalled product. The product was shipped to customers in the following states - Arkansas, Colorado, Louisiana, Oklahoma and Texas. We have notified the Food & Drug Administration about the recall.
