

SUBJECT: ALFOODACT 007-2004- Multi-Serv, Frozen, Lasagna With Meat And Sauce
DATE ISSUED: June 15, 2004

1. REFERENCE:

2. BACKGROUND:

A routine inspection of the subject lasagna yielded serious findings that affect the product's usability. The packaging showed signs of deterioration to the point of disintegration when touched, causing contamination of the product. The Army Veterinary Service has concluded that the lasagna poses a potential food safety risk, and should be recalled from distribution as soon as possible.
