

SUBJECT: ALFOODACT 012-2006: Oklahoma Firm Recalls Meat Products That May Contain Pieces of Metal (Update)
Date Issued: June 2, 2006

2. BACKGROUND: Advance Food Co., an Enid, Okla., establishment is voluntarily recalling approximately 4.3 million pounds of frozen meat products that may contain pieces of metal.

3. PRODUCTION DATES/IDENTIFYING CODES:

All raw breaded product associated with this recall will have a code date as follows (the # sign indicates numbers that will vary):

All code dates that begin with the letter J or K that appear as follows:

This recall does NOT include any cooked product, raw unbreaded product, or product that does not carry the Y4 at the end of the code date. It also does not include any that appear as K0##5####Y4 or K0##6####Y4.

Each package also displays the establishment number "EST. 2260Y" or "EST. 2260G" inside the USDA seal of inspection.

7. INSTRUCTIONS AND ADDITIONAL INFORMATION FOR MESSAGE RECIPIENTS:

(1) Immediately inventory stocks to identify the above items and secure in a "Medical Hold" status to provide assurance of no further issue/sale/use of the item.

(2) Ships at sea are authorized to destroy or dispose of recalled products at their discretion. Documentation for the number of pounds and cases, and any additional pertinent information must be signed by the Accountable Officer and is required for the purpose of recouping to the government the cost of the product involved. Information shall be forwarded by priority message to this center.

(3) Accountable Activities should return recalled product to the manufacturer through the appropriate distribution channels.
