2. BACKGROUND:

Government Officials have associated the consumption of tortillas with a series of health symptoms.

3. PRODUCTION DATES/IDENTIFYING CODES:

The affected products are all sizes and types of flour tortillas with the brand name Del Rey and a use by date prior to March 6, 2006.

The recall does not affect flour tortillas made on or after January 20, 2006, which will have a use by date of March 9, 2006 or later, or any other Del Rey Tortilleria products.

6. QUANTITY RECALLED: Unknown

7. REASON FOR RECALL: Government Officials have associated the consumption of tortillas with a series of health symptoms.

8. INSTRUCTIONS AND ADDITIONAL INFORMATION FOR MESSAGE RECIPIENTS:

(1) Immediately inventory stocks to identify the above items and secure in a "Medical Hold" status to provide assurance of no further issue/sale/use of the item.

(2) Ships at sea are authorized to destroy or dispose of recalled products at their discretion. Documentation for the number of pounds and cases, and any additional pertinent information must be signed by the Accountable Officer and is required for the purpose of recouping to the government the cost of the product involved. Information shall be forwarded by priority message to this center.

(3) Accountable Activities should return recalled product to the manufacturer through the appropriate distribution channels. Product should clearly be marked with "Recalled Product."
