7. INSTRUCTIONS AND ADDITIONAL INFORMATION FOR MESSAGE RECIPIENTS:

a. Immediately inventory stocks to identify the above items and secure in a "Medical Hold" status to provide assurance of no further issue/sale/use of the item.

b. Ships at sea are authorized to destroy or dispose of recalled products at their discretion. Documentation for the number of pounds and cases, and any additional pertinent information must be signed by the Accountable Officer and is required for the purpose of recouping to the government the cost of the product involved. In order to get

credit please use a SF 364 and forward to your supporting FISC and copy furnished to NAVSUP 51. Your supporting FISC should forward to the account manager at DSCP. The form should include the number of the recall authorizing the survey action. Home ported ships/gallies will utilize DD form 1149 to transfer w/ reimbursement to the PV. The PV will submit credit invoice to the account manager at DSCP.

c. **POSITIVE RESPONSES** should be reported to Accountable Officers/Vendor Representatives of that facility. Return recalled product to the manufacturer through the appropriate distribution channels for replacement and/or credit. It may be more feasible for overseas location to seek reimbursement/credit and destroy at location.

d. Unless otherwise specified above, **POSITIVE and NEGATIVE RESPONSES** directly to DSCP Consumer Safety Officer (CSO) are **NOT** required. Notify your normal chain/representative for refund/credit/replacement.
