2. BACKGROUND :

ALFOODACT 025-2007 recalled Nissin Foods (USA) Co., Inc. Nissin Cup Noodle Shrimp and Nissin Original Chow Mein Shrimp due to an undeclared allergen. Nissin has since corrected the package labeling and resumed production of the below listed items.

Resume purchase/sale on products listed below with a production date beginning 27 July 2007. Product package will have a use by date beginning 27 July 2008 which corresponds to the one year shelf life.
