

Subject: ALFOODACT 103-2009 Ball Park® Beef Franks Being Recalled Because of Undeclared Allergen

Date Issued: March 26, 2009

2. BACKGROUND:

Ball Park is voluntarily recalling a partial production run of the following product as a precautionary measure as the product may contain cheese, an undeclared milk allergen, posing a potential health risk to milk-allergic individuals. The product may also contain undeclared poultry and pork. This recall affects 1,728 pounds of product and is due to an error in packaging in which Ball Park Cheese Franks were packaged in Ball Park Beef Frank packaging.

3. PRODUCTION DATES/IDENTIFYING CODES:

***USE BY May 07 09 P8740A Only

Only packages labeled as Ball Park Beef Franks with UPC CODE 5450010002 and USE BY May 07 09 P8740A printed on the back of the packaging are part of this recall. No other Ball Park branded products is affected.

6. REASON FOR ACTION: Undeclared Allergen

7. INSTRUCTIONS AND ADDITIONAL INFORMATION FOR MESSAGE RECIPIENTS:

- a. Immediately inventory stocks to identify the above items and secure in a "Medical Hold" status to provide assurance of no further issue/sale/use. POSITIVE FINDINGS should be reported to the Contracting Officers or Accountable Officers/Vendor Representatives of that facility. Accountable Officer/Agency representatives/Buyers/Contracting Officers should seek refund/credit/replacement through the normal distribution channel with which the product was received (i.e. Distribution Centers, Prime Vendors, Manufacturers, etc.).

b. Ships at sea are authorized to destroy or dispose of recalled products at their discretion. Documentation for the number of pounds and cases, and any additional pertinent information must be signed by the Accountable Officer and is required for the purpose of recouping to the government the cost of the product involved. In order to get credit please use a SF 364 and forward to your supporting FISC and copy furnished to NAVSUP 51. Your supporting FISC should forward to the account manager at DSCP. The form should include the number of the recall authorizing the survey action. Home ported ships/gallies will utilize DD form 1149 to transfer w/ reimbursement to the PV. The PV will submit credit invoice to the account manager at DSCP.

c. Except for Prime Vendors, POSITIVE and NEGATIVE RESPONSES directly to DSCP Consumer Safety Officer (CSO) are NOT required. Prime Vendors should report finding to their assigned Contracting Officer and courtesy copy the Consumer Safety Officer (dscpconssafofc@dla.mil). Other agencies such as DeCA, AAFES, MWR, VA, MCCA, etc. should report POSITIVE and NEGATIVE responses to their agencies recall coordinator.
