

**SUBJECT:** ALFOODACT 011-2010 Pringles Super Stack Restaurant Cravers Cheeseburger and Family Faves Taco Night

**Date Issued:** March 09, 2010

**1. REFERENCES:**

**2. BACKGROUND:** P&G voluntarily recalling two SKU's of Pringles flavors in the United States in response to FDA industry guidance. In order to simplify the process for retailers, P&G will also discontinue these two SKU's. The two items are Pringles Restaurant Cravers Cheeseburger UPC 37000 26936 and Family Faves Taco Night UPC 37000 26773. P&G was notified by one of its suppliers that a seasoning used in these two products contains hydrolyzed vegetable protein (HVP) manufactured by Basic Food Flavors, Inc., who has voluntarily recalled several lots of this ingredient because of potential salmonella exposure. No other Pringles varieties or flavors are affected by this recall.

**3. PRODUCTION DATES/IDENTIFYING CODES:**

Pringles Restaurant Cravers Cheeseburger, Super Stack Canister, 181 Grams, UPC:37000 26936. "Best By" dates: 02/2011 and 04/2011

Pringles Family Faves Taco Night, Super Stack Canister, 181 grams, UPC: 37000 26773. "Best By: dates: 03/2011, 04/2011, and 05/2011.

The "best by" date for each product can be found on the bottom of the can.

**4. MANUFACTURER/DISTRIBUTOR:**

Procter & Gamble

**5. DISTRIBUTION:** Nationwide. Positive in Defense Commissary Agency (DeCA).

**6. REASON FOR ACTION:** Products may cause adverse health consequences.

**7. INSTRUCTIONS AND ADDITIONAL INFORMATION FOR MESSAGE RECIPIENTS:**

a. Immediately inventory stocks to identify the above items and secure in a "Medical Hold" status to provide assurance of no further issue/sale/use. POSITIVE FINDINGS should be reported to Accountable Officers/Vendor Representatives of that facility. Accountable Officer/Agency representatives/Buyers/Contracting Officers should seek refund/credit/replacement through the normal distribution channel with which the product was received (i.e. Distribution Centers, Prime Vendors, Manufacturers).

b. Ships at sea are authorized to destroy or dispose of recalled products at their discretion. Documentation for the number of pounds and cases, and any additional pertinent information must be signed by the Accountable Officer and is required for the purpose of recouping to the government the cost of the product involved. In order to get credit please use a SF 364 and forward to your supporting FISC and copy furnished to NAVSUP 51. Your supporting FISC should forward to the account manager at DSCP. The form should include the number of the recall authorizing the survey action.

Home ported ships/galleys will utilize DD form 1149 to transfer w/ reimbursement to the PV. The PV will submit credit invoice to the account manager at DSCP.

c. Except for Prime Vendors, POSITIVE and NEGATIVE RESPONSES directly to the DSCP Consumer Safety Officer (CSO) ARE NOT required. Prime Vendors should report findings to their DSCP Contracting Officer with a courtesy copy to the Consumer Safety Officer ([dscpconssafofc@dla.mil](mailto:dscpconssafofc@dla.mil)). Other agencies such as DeCA, AAFES, MWR, VA, MCCS, etc. should report POSITIVE and NEGATIVE responses in accordance with their agency recall policies.
