


- This bridge contract includes administrative contract SPM300-10-D-3133 to replace the existing administrative contract SPM300-08-D-3133 and extends the expiration date through May 21, 2011.
- The funding amount for this contract will be \$2,500,000.00 (the guaranteed minimum) with an allowable 150% maximum ceiling limitation as the effective contract dollar value.
