To: All Suppliers Receiving Orders for Medical Materiel for Overseas Shipment

The Medical Air Bridges (MAB) and the Defense Distribution Norfolk Virginia (DDNV) are part of a ten-year DoD Major Defense Acquisition – Automated Information System project. The mission to modernize the entire military health care system includes the expedited delivery of high priority medical materiel to our Warfighters. The MABs and DDNV serve as transshipment points where supplies are consolidated and shipped in bulk to overseas destinations, providing immediate support to our warfighters.

Although customers for our supplies have been given instructions on using the MABs and DDNV, many still fail to include these transshipment points on their orders. Because so much of our logistics system is now automated, from receipt of the requisition to awarding the procurement, it is now even more difficult for us to identify when orders are not utilizing MAB or DDNV as transshipment receiving points. Identifying orders that may require shipment to an MAB or DDNV relies mainly on our vendor community to spot them.

Any order issued by DLA Troop Support for medical materiel with an overseas destination is subject to the following shipping instructions which take precedence over the ship-to addresses provided on each order. If you receive an order destined for an overseas location, please follow these instructions. If you are not sure if shipment to an MAB or DDNV is appropriate, please call the administrator identified on the order. They will provide you with the proper guidance.

We are also in the process of examining alternate solutions to this situation, namely solutions that can be system-generated. In the meantime, your cooperation in shipping medical material to the appropriate MAB or DDNV will ensure expeditious delivery of vital supplies to our troops overseas.

*The TCN (or Mark-For Address) can be found on each order you receive requiring overseas shipment. The TCN must appear on the shipping label that you create. The TCN (or Mark-For Address) consists of the Service, the Unit Identification Code (UIC) and a Julian date & serial number. For example, in the TCN "V026370032TH21," the "V" signifies the Navy; the UIC is 02637 (identifies the individual ship), Julian date 0032 and serial #TH21.

The TCN number is a vital piece of information that must be visible on the shipping label that is placed on the outside of the box or pallet. Failure to affix the TCN number will result in a frustrated shipment.

There are no restrictions on the type of items that can be sent to DDNV.

Note: **A Material Safety Data Sheet (MSDS)** is required for all hazardous materiel/ORM Materiel. If you are shipping any type of hazardous materiel/ORM, please ensure the MSDS is in the box or package.

Note: **Temperature Controlled Items:** A temperature control label must be affixed to the outside shipping container for all temperature- controlled items (or orders). The label will help to quickly identify temperature-sensitive items which will facilitate in properly storing and distributing the material.
